



## 2024 PAPERS MEMBERSHIP and SPONSOR FEES

A current PAPERS membership is required for attendance at conferences and for participation in the Public Pension Professional certification program. Any number of representatives from an organization which qualifies for the group-based Participating, Associate or Affiliate categories of membership may attend PAPERS annual conferences upon payment of the applicable registration fee for each event. Sustaining Membership is the only individually based category of membership as noted below.

### **PARTICIPATING MEMBERSHIP** - Public pension plans in the Commonwealth of Pennsylvania

Annual dues for public pension plans are:

**Early bird rate** (*paid on or before 3/31/2024*) - \$125; **Standard rate** (*paid after 3/31/2023*) - \$150

- Spring Forum registration fee for each Participating Member representative: early bird - \$125; standard - \$150
- Fall Workshop registration fee for each Participating Member representative: early bird - \$125; standard - \$150

### **ASSOCIATE MEMBERSHIP** - Annual corporate dues are \$1,500

*Asset managers and firms providing investment management and/or legal services to public pension funds*

- Spring Forum registration fee for each Associate Member representative: early bird - \$750; standard - \$825
- Fall Workshop registration fee for each Associate Member representative: early bird - \$750; standard - \$825

### **AFFILIATE MEMBERSHIP** - Annual corporate dues are \$750

*Firms, organizations, unions and consultants providing services to public pension plans, exclusive of investment management and legal services*

- Spring Forum registration fee for each Affiliate Member representative: early bird - \$375; standard - \$425.
- Fall Workshop registration fee for each Affiliate Member representatives: early bird - \$375; standard - \$425

### **SUSTAINING MEMBERSHIP** - Annual dues for eligible individuals are \$75

*Individual membership available only to those persons with an interest in public pensions but not affiliated with an organization which qualifies for group membership in any other category.*
